

MoneyHero x Webull 條款及細則 (以下稱「推廣活動」) (202604)

1. 於推廣期內，透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/03/31 4pm 至 2026/04/30 4pm, 包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定賬戶」是指 Webull證券戶口。
- b. 「產品供應商」是指 Webull Securities Limited。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立微牛證券賬戶及從未領取任何微牛迎新開戶獎賞的客戶。

4. 合資格客戶

- HK\$2,800 惠康購物現金券; 或
- HK\$2,800 HKTvmall電子購物禮券; 或
- 30,000 Max Miles 飛行里數; 或
- Dyson Supersonic Nural™ 風筒 HD16 (價值HK\$3,980); 或
- Dyson HushJet™ Purifier Compact 空氣清新機 HJ10 (價值HK\$3,190).

- b. 合資格客戶將最多獲得1個推廣獎賞。

Terms and Conditions of MoneyHero x Webull (the “Promotion”) (202604)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/03/31 4pm until 2026/04/30 4pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion

- a. “**Designated Account**” means the Webull Securities Account.
- b. “**Product Provider**” means Webull Securities Limited.
- c. “**New Customer**” means Customers who have not opened a Webull Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

- d. - HK\$2,800 Wellcome Shopping Voucher; OR
- HK\$2,800 HKTVMall e-Shopping Voucher; OR
