

MoneyHero x Webull 條款及細則 (以下稱「推廣活動」) (202609)

1. 於推廣期內，透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/09/08 12pm 至 2026/09/30 4pm, 包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定賬戶」是指 Webull證券戶口。
- b. 「產品供應商」是指 Webull Securities Limited。

 - HK\$2,400 惠康購物現金券; 或
 - HK\$2,400 HKTVmall 電子購物禮券; 或
 - 25,000 Max Miles 飛行里數; 或
 - Dyson HD16 Supersonic Nural™ 風筒 (價值HK\$3,980); 或
 - Philips ADD6920 RO純淨飲水機 (價值HK\$4,288); 或
 - DELONGHI DEDICA DUO EC890 半自動咖啡機 (價值HK\$3,588); 或
 - Dyson CameraJet™ 水牙線電動牙刷 (價值HK\$4,290) (需以換購價HK\$2,000換領).
- iii. 經MoneyHero成功註冊有效的Webull證券賬戶，開戶30天內累計淨入金[^]存入 **HK\$500,000** 或以上，並第31天起計維持資30天
- HK\$500 Apple Store 禮品卡.

*禮品「周生生「珍藏篇」999.9黃金小馬 (1克) × 1件」限量共 10 名額，數量有限，先到先得。超出之名額將以 HK\$1,000 惠康購物現金券作為替補禮品。

Terms and Conditions of MoneyHero x Webull (the “Promotion”) (202609)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/09/08 12pm until 2026/09/30 4pm, dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion

- a. “**Designated Account**” means the Webull Securities Account.
- b. “**Product Provider**” means Webull Securities Limited.
- c. “**New Customer**” means Customers who have not opened a Webull Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

- HK\$2,400 Apple Store Gift Card; OR
 - HK\$2,400 Wellcome Shopping Voucher; OR
 - HK\$2,400 HKTVmall e-Gift Voucher; OR
 - 25,000 Max Miles; OR
 - Dyson HD16 Supersonic Nural™ Hair Dryer (value at HK\$3,980); OR
 - Philips ADD6920 RO Water Dispenser (value at HK\$4,288); OR
 - DELONGHI DEDICA DUO EC890 Pump-driven Espresso Coffee Machine (value at HK\$3,588); OR
 - Dyson CameraJet™ Water Flosser Electric Toothbrush (value at HK\$4,290) (Need to redeem at the redemption price of HK\$2,000).
- iii. Successfully opened a Designated Account via MoneyHero, deposited **HK\$500,000 or above** into the Designated Account within 30 days from the date of opening the Designated Account, and maintained the net deposited balance for 30 consecutive days starting from the 31st day:
- HK\$500 Apple Store Gift Card.
