

# MoneyHero x uSmart 條款及細則 - (以下稱「推廣活動」) (202606)

1. 於推廣期內透過MoneyHero申請指定賬戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為 2026/05/29 6pm 至 2026/06/30 6pm，包括首尾兩日(以下稱「推廣期」)。

## 3. 推廣活動相關定義

- a. 「指定賬戶」是指uSmart證券戶口。
- b. 「產品供應商」是指uSmart證券。
- c. 「新客戶」是指獎勵活動對象為18歲或以上並且在推廣期前未曾開通uSMART盈立證券賬戶及存入資金的人士，只限持有香港居民身份證或持海外護照的人士。

## 4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 成為年滿18歲或以上，持有有效香港身份證並擁有香港通訊地址的新客戶；
- b. 在推廣期內透過MoneyHero使用指定連結完整填寫並提交指定賬戶的申請；

- d. 其指定賬戶的申請需獲產品供應商批准，並在2026/06/30 6pm或之前完成開戶手續，根據產品供應商的系統記錄；及
- e. 為獲得某些推廣獎賞，需在指定賬戶中存入至少HK\$10,000並保持至少30天。

## 5. 推廣獎賞及兌換

- a. 完成上述第4條規定條件的合資格客戶，根據所達成的條件(視供應情況而定)，可選擇以下「推廣獎賞」之一：

# Terms and Conditions of MoneyHero x uSmart - (the “Promotion”) (202606)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2026/05/29 6pm to 2026/06/30 6pm, dates inclusive (the “Promotion Period”).

## 3. For the purposes of this Promotion:

- a. “Designated Account” means the uSmart Account.
- b. “Product Provider” means uSmart .
- c. “New Customer” means customers who are aged 18 or above and have not opened a uSmart Brokers account or made a deposit before and only for customers who are holding a Hong Kong identity card.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “Eligible Customers”, customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link during the Promotion Period;
- c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Account within the Promotion Period (and in any event no later than 2026/07/05, including providing their uSmart Account ID (8 digits) in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;
- d. Have their application for the Designated Account approved by the Product Provider and complete the account opening procedure on or before 2026/06/30 6pm, according to the Product Provider’s system records; and
- e. In order to receive certain Promotion Rewards, deposit at least HK\$10,000 into the Designated Account and maintain the same for at least 30 days.

## 5. Promotion Rewards and Redemption
